- Austin Transit Partnership's Procurement Policy and Guidelines, specifically Section 1-101B Standards of Conduct and ATP Conflicts of Interest, that speaks to contact with vendors and contractors prior to issuance of a solicitation and after issuance but prior to contract award. The ATP Procurement Policy and Guidelines was adopted on September 15, 2021, through Board Resolution 2021-027.
