## **ITEM FROM BOARD**

<u>Subject</u>: Approval of first amendment to Executive Director employment contract and reappointment as Executive Director.

## **Executive Summary:**

The Austin Transit Partnership Board of Directors approved Resolution ATP-2023-0004 on March 1, 2023, which appointed Gregory Canally as Executive Director of Austin Transit Partnership and authorized the Board Chair to negotiate and execute an employment contract for a contract term of three years (the "Employment Agreement"). The initial Employment Agreement was executed on April 16, 2023.

The ATP Board desires to amend the Employment Agreement with Gregory Canally as the Executive Director of ATP, effective March 1, 2025, (the "Effective Date"), as well as to include revisions to the Executive Director's title and compensation structure. This resolution also reappoints Gregory Canally as Executive Director for a two-year term in accordance with the ATP Bylaws. From and after the Effective Date, the Executive Director shall continue to generally supervise and control all the business and affairs of ATP in accordance with Section 3.4 of ATP's Bylaws.
